These Regulations revoke regulation 9(7) of the 2011 Regulations to avoid any possible implication that the English and Welsh versions of the strategies are treated differently.

The Committee noted that the Regulations are made pursuant to the Deputy Minister's response in the Plenary debate on the 6th December 2011 to the Committee's Report dated 2 December 2011 on the 2011 Regulations. The Committee decided to write to the Deputy Minister for Children and Social Services, Gwenda Thomas AM, to express this appreciation.

European Commission draft proposal for a directive on public procurement - Possible Subsidiarity Issue

The Committee considered the letter from the Chair of the Enterprise and Business Committee Nick Ramsay AM and the Chair of the Task and Finish Group on EU Procurement policy Julie James AM to the Minister for Finance and Leader of the House expressing the Enterprise and Business Committee's concerns about two aspects of the European Commission draft proposal for a directive on public procurement¹. The Committee considered the legal implications of the

proposal and agreed to lay before the Assembly a report expressing its concerns regarding the subsidiarity aspect of the proposed 'national oversight body' (Article 84.1 of the draft Directive) and to raise these concerns with the relevant European Committees of the UK Parliament, in accordance with the early warning mechanism identified in Protocol 2 of the Treaty of Lisbon².

The Committee also agreed to write to the European Commission to express its concerns directly, whilst recognising that this will not be considered as part of the formal process of the subsidiarity early warning mechanism.

Title: The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amendment) Regulations 2012

Procedure: Negative

These Regulations will amend The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000 ("The 2000 Regulations"). The Regulations stipulate a new design for the Blue Badge, the Blue Badge fee, improves the administration and enforcement of the scheme, and makes a minor amendment to the eligibility criteria.

Technical Scrutiny

The following point is identified for reporting under Standing Order 21.2 in respect of this instrument.

The English version of these Regulations refers to Schedule 1; however the Welsh version of these Regulations merely refers to the number 1, but has omitted to refer to "Schedule". Consequently, the insertion of Schedule 1 by regulation 2 (9) (c) of the Welsh version into the 2000 Regulations will be inoperable, as Schedule 1 does not exist. The Committee was content that this could be corrected on publication.
