The Committee considered CLA CM3 - Consent Memorandum for The British Waterways Board (Transfer of Functions) Order 2012. Although, on legal and constitutional grounds, there appeared to be no reason why consent should be withheld from the Order, there were concerns about whether the Consent Memorandum provided sufficient information, particularly about the scope of the Order and its relationship to the extensive legislative competence of the Assembly, to allow the Committee (and other Committees) to consider it properly. The Committee agreed to report that while it did not recommend

withholding consent from the Order it had a number of concerns about the adequacy of the information set out in the Consent Memorandum.
