- 2. To receive a breakdown of the numbers of staff at each grade, employed by the Assembly, who are identified as speaking Welsh (at whatever level of competence).

A copy of the Equality Impact Assessment (EQIA) undertaken in relation to the Assembly Commission's Official Languages Scheme has recently been published on the Assembly Commission's Diversity and Inclusion webpages. Preparing an EQIA was an integral part of the planning and development of the new Official Languages Scheme. The document sets out a number of risks and mitigations identified to ensure that the themes for improvement in the scheme do not adversely affect the wider community. It has been independently verified by an external equalities organisation.

We do not hold the requested information on language skills levels by grade. However, the Assembly Commission conducted a language skills audit in 2015. 374 members of staff completed the survey, and of those who completed the survey, 291 indicated that they have a level of spoken welsh ranging from 'a little' to 'fluent'.
