Please provide the procedural mechanism by which Dafydd Flis-Tho

Thank you for your request received 20 October in which you asked:

Please provide the procedural mechanism by which Dafydd Elis-Thomas and Nathan Gill retain a seat on the Constitutional and Legislative Affairs Committee when neither currently has a mandate, having resigned from their original parties who retain the mandate.

The relevant procedures are set out in the National Assembly's Standing Orders, which can be accessed via http://www.assembly.wales/en/bus-home/Pages/bus-assembly-quidance.aspx. Please note:

- Dafydd Elis-Thomas ceased to be a Member of the Constitutional & Legislative Affairs Committee when he left the Plaid Cymru political group in the National Assembly (as prescribed by Standing Order 17.12; the definition of a political group can be found at Standing Order 1.3).
- Nathan Gill was not a Member of the Constitutional & Legislative
 Affairs Committee at the time he left the UKIP political group in the
 National Assembly. Standing Orders 17.13 to 17.15 set out the
 procedure followed by the Business Committee which resulted in the
 Assembly (in Plenary) agreeing to appoint him as a Member of that
 Committee. (See also Standing Order 17.10 which specifies that every
 Member who does not belong to a political group must be offered a
 place on at least one committee.)
