1. The <u>consultation document</u> published in December 2016 provides some information about potential financial implications. - 2. In a letter from the Llywydd to all <u>Assembly Members</u>, the Llywydd set out her intention that the name change introduced in the Bill should be the monolingual name "Senedd". This proposal will be subject to detailed consideration by the Assembly during the passage of the Bill. A detailed estimate of the costs associated with legislating to rename the Assembly as Senedd will be published alongside the Bill, when it's introduced early next year as required by the Assembly's Standing Orders. This document is intended for future publication and is exempt from disclosure under section 22 of FOIA.

 All of the Bill's documentation will be published on the <u>Assembly Reform programme webpage</u>. You may also wish to sign up to receive email updates on the Assembly Reform programme and you will be automatically notified of the Bill's introduction (as well as all updates in relation to Assembly reform).
- 3. The 2017-18 <u>annual report</u> (page 116) provides you with this information, broken down into the categories of employed, seconded and agency staff. As this information is already published, this part of your request is subject to section 21 of the Freedom of Information Act 2000 (FOIA) which exempts information that is already reasonably accessible by other means i.e. already published on our website.
- 4. Again, this information is published on page 124 of the annual report. A table specifies the staff salaries and related costs. As this information is already published, this part of your request is subject to section 21 of the Freedom of Information Act 2000 (FOIA) which exempts information that is already reasonably accessible by other means i.e. already published on our website.
- 5. As at the end of September 2018, 253 Assembly Member Support Staff were employed.
- 6. Page 146 of the annual report provides you with this information, broken down into three categories: permanent, temporary and agency, and seconded staff. As this information is already published, this part of your request is subject to section 21 of the Freedom of Information Act 2000 (FOIA) which exempts information that is already reasonably accessible by other means i.e. already published on our website.
