A copy of the Equality Impact Assessment (EQIA) undertaken in relation to the Assembly Commission's Official Languages Scheme has recently been published on the Assembly Commission's <u>Diversity and Inclusion webpages</u>. Preparing an EQIA was an integral part of the planning and development of the new Official Languages Scheme. The document sets out a number of risks and mitigations identified to ensure that the themes for improvement in the scheme do not adversely affect the wider community. It has been independently verified by an external equalities organisation.

The group has already met to agree its terms of reference and membership, and will commence work shortly on defining and agreeing the language skills levels that will be used from summer 2018. The levels will be based on the internationally acknowledged Association of Language Testers in Europe (ALTE) model.

3. A definition of "basic linguistic courtesy"

At its first meeting on 20 July, the working group referred to above agreed a working definition of basic linguistic courtesy that will be used to begin work on the actions outlined in the theme for improvement on recruitment. The working definition is as follows:

- To pronounce Welsh names, answer the telephone, greet people or make introductions bilingually
- To understand and use proactively familiar, everyday, expressions
- To understand very short texts where people are giving basic information about themselves or others in correspondence, on forms or to interpret content using the technology available.
