Thank you for your request received on 5 September in which you asked:

Under the freedom of information act, I request information of all the financial costs associated with the National Assembly for Wales Sustainability Committee inquiry in to access to water dated the 1st of May 2009 to the 31st of July 2010 to include all legal costs, stakeholder engagement events, details of venues and dates of such events and methods of collating evidence. I request copies of all documents relating to stakeholder and Sustainability Committee meeting dates, venues, attendees lists and minutes.

Please find our response to your questions below.

In June 2010, the Sustainability Committee launched its report following an <u>Inquiry into access to inland water in Wales</u>. 'The report' provides details of the meetings it held to gather evidence and engage with stakeholders.
