*Can you provide me with an up to date Food and Drinks menu for the Senedd communal members' bar/restaurant area together with the actual cost to Senedd members.*

Please see our response to your request below.

The Senedd estate has been closed since March 2020 due to the Covid-19 pandemic, with only limited numbers of people allowed onto the estate. As a result of this, catering services have been running at reduced capacity. We are unable to provide you with a food menu as we do not hold the information requested but we do hold the Members' Tea Room tariff and this is captured below.
