## Request for Information.



Thank you for your request received 3 November in which you asked:

*Microsoft have recently announced price changes to their products and services which I understand your organisation uses. Could you provide me with how many Microsoft licenses (for example for Office365, servers, email software and so on) you currently have, and what impact this price change will have. For example, if your current arrangement is to buy direct from Microsoft and the contract is up next year – what increase are you expecting? Similarly if you purchase the software through a third party or reseller, based on the number of licences you currently have, what is the expected increase in cost in 2017?*

The table attached provides you with the information requested in terms of the number of licenses we currently have.

The price changes that you mention will not affect the Assembly Commission for the next 3 years as our current agreement with Microsoft is renewed before the increase comes into effect.

Your request has been considered according to the principles set out in the Code of Practice on Public Access to Information.
