- 2. Please identify, by title or job description, those members who are provided with a motor vehicle (car/van) at no cost to themselves.
- 3. Please provide the total number and types of vehicles provided by the Welsh Assembly (WAG) to: a) elected Members, b) Officers, c) other Employed staff and d) any other person.
- 4. Please provide details of the 'terms of use' of the vehicle, for each category in 3. above including the use by a 'Supervisor' employee, whether on a once only journey, daily or continuous basis.
- 5. Please provide details on what basis these vehicles are acquired, i.e. short-term rental, long-term rental, purchased, or other.
- 6. Please provide the identity of the Company/ies providing these vehicles(cars/vans).
- 7. Please provide the annual cost of each individual vehicle. i.e. the total annual expense incurred (rental or purchase cost, fuel, mileage, service, MOT, licence, repairs, insurance, parking, tolls, ferries, etc.) for each Welsh Assembly (WAG) member provided with a vehicle.
- 8. Please provide details of any device, GPS, radio, telephone, etc. installed on vehicles or provided to Welsh Assembly (WAG) staff members and for what purpose.
