- 3. The number of staff in the National Assembly for Wales' legal team.
- 4. A breakdown of those roles (ie the number of lawyers and other staff) in the National Assembly for Wales' legal team

Our response to your requests are detailed below.

1. The salary paid to Elisabeth Jones is published in our <u>Annual Report and Accounts 2017–18</u> under the heading <u>Commission senior staff</u> (page 110 onwards). Previous annual reports can also be found on our <u>website</u>. Please note that the role of Elisabeth Jones is Chief Legal Adviser. The Assembly Commission does not employ a Director of Legal Services.
