Dear Member

I am writing regarding the proposed M4 to A48 link road, after this issue was raised in the Senedd during the Business Statement on 8 May.

We allocated £60,000 to the Vale of Glamorgan Council in 2017/18, under the Local Transport Fund Grant, to undertake a Welsh Transport Appraisal Guidance (WelTAG) appraisal for the provision of highway improvements from the A48 Sycamore Cross junction to junction 34 of the M4. The project is being led by the Council.

The purpose of the Stage One work was to understand the issues of concern, explore the context and present a wide list of possible solutions. This would inform a decision on whether there are any solutions within the transport sector that are worth pursuing and to select a short list of options for more detailed consideration. We commissioned Peter Brett Associates to assess the 'Case for Change' for addressing connectivity issues for strategic employment sites in the Vale of Glamorgan. This work was undertaken alongside the WeITAG Stage One process. The purpose of this study was to clearly demonstrate the 'Case for Change', providing a clear rationale for making an investment, its strategic fit, and how the investment will further the aims and objectives of Welsh Government and its partners.

Albeit not a statutory requirement, the Council is currently undertaking a consultation as part of the WeITAG Stage Two process. The purpose of the Stage Two work is to examine in greater detail the short list of options for tackling the problem under consideration. This is still an early stage of the project and there is opportunity to comment on the options put forward and to suggest alternatives for consideration.

The consultation has been extended and will close on 17 July. The Council is also providing the opportunity for residents to discuss the proposals in more detail with one of
